- 1. The Renter/User is responsible for the compliance with all applicable federal, state, and local regulations, ordinances, and executive orders while utilizing the facilities in the Gwinnett County Parks.
- 2. Gwinnett County Parks and Recreation reserves the right to retain any portion of the security deposit if all rental conditions are not met. If cleaning fees or damages exceed the deposit amount, additional fees will be billed to the renter
- 3. Gwinnett County Parks and Recreation reserves the right to cancel any facility rental at any time
- 4. Special activities such as nonprofit fundraising, use of commercial food or recreation vendors, etc., must have prior approval
- 5. Rentals with an outside caterer/restaurant on site during the rental hours to serve/distribute food or beverages must complete a Food Service Authorization and Indemnification form at least two weeks prior to the rental date
- 6. The renter is responsible for any and all damage incurred to the facility or grounds during the rental period
- 7. Clean-up includes removing all litter, signs and ashes from fire rings/grills. All trash receptacles emptied and trash taken to the dumpster. If the campground is not left in a clean condition, cleaning fees will be deducted from the security deposit
- 8. The renter must adhere to the rental start and finish times, including set-up and clean-up
- 9. It shall be unlawful for any person to possess, use, sell or consume any alcoholic beverage in a park or recreation facility, except when approved, by permit, at the Gwinnett Historic Courthouse, Pinckneyville Park Community Recreation Center, Lawrenceville Female Seminary, Isaac Adair House and Preservation Lawn, Simpsonwood Park Chapel and Grounds or the Gwinnett Environmental and Heritage Center
- 10. Amplified sound is prohibited

- 11. Motorized or electric vehicles such as ATV's, lawn mowers, golf carts, or other vehicles not licensed for road travel are prohibited
- 12. Pyrotechnics, hobby rockets, or any other related objects is prohibited
- 13. Rentals must have adult supervision. One adult, 21 years of age or older, for every ten youths is required
- 14. Renting the camping area only includes the exclusive use of the camping area. Rental does not include parking lots, pavilions or other surrounding areas. We do not guarantee power or water at the restroom or other areas
- 15. Gwinnett County Parks and Recreation will only approved camp fires if 1) outdoor burn ban is not in effect 2) adult supervision is provided at all times 3) winds are less than 5mph. Fires must be contained in fire rings or in grills. Fire rings must be completely extinguished at the end of the rental. Fire can only be ignited by kindling or solid wood fire starters, no chemical agents permitted. Renters must provide firewood/kindling for the fire rings, no paper, pine needles, or leaf burning is permitted. Ash from fire rings/charcoal grills must be placed in ash bin
- 16. Renters will be issued a key to the restrooms, which will be prepared prior to the rental. Renters should bring additional supplies. The key must be returned by the close of business the following working day
- 17. A Recreation Park Attendant will be on park property for the first two hours of the rental to review campground operations, fire extinguishing guidelines, provide a check list, assist with prepping the restrooms and grill, and restocking supplies prior to the rental
- 18. Equipment such as grills, propane stoves, etc. must have prior approval and must remain in designated area. All waste disposal from cooking units is the responsibility of the renter. Nothing may be dumped on park property
- 19. Renter may display a sign/banner about their rental only during the rental time. Gwinnett County Parks and Recreation reserves the right to remove any banner deemed inappropriate. Banners/signs may not be attached to trees, signs, or other fixed items. Renter must provide stakes to secure sign/banner
- 20. In the case of inclement weather, cancellations are not assumed; notification by the renter is required
- 21. When Gwinnett County Government is closed due to inclement weather, all rentals are cancelled and will be rescheduled at no additional fee to the renter. In case of inclement weather on weekends, GCPR staff will inform rental groups regarding the status of the rental
- 22. If a rental needs to be rescheduled or extended, or the number of people needs to be changed, the facility where the reservation was made must be notified to evaluate availability and/or capacity. Requests or changes made less than 7 days in advance of the rental will not be honored. A credit, good for 1 year, will be issued in the amount of any decrease in rental fee resulting from a change
- 23. Gwinnett County Parks are a Tobacco-Free Park System! This tobacco-free policy restricts the use of any tobacco product that contains tobacco or nicotine within a County park site.
- 24. Cancellations must be received in writing or no refunds will be issued. Refunds will be sent by mail within 2-6 weeks of request if paid by check, cash, or money order. If paid by credit card, refunds will be issued within 7 business days. (Please check with your bank if there are delays on it showing up on your card) The \$1 processing fee is non-refundable. Refunds will be issued in the following manner:

In writing 30 days prior to the event 100% Refund of rental fees, less \$25 cancellation fee

In writing 29 - 8 days prior to the event 50% Refund of rental fees, less \$25 cancellation fee

In writing 7 days or less 0% Refund of rental fees, program credit only

- 2. The association agrees to abide by the regulations herein provided and understands that the violation of any of the following regulations would cause the organization to be barred from the use of the facility. Prior to negotiation of this permit, the organization must meet the requirements as issued in the youth athletic association Policies and Procedures Manual
- Gwinnett County Athletic Associations that utilize Gwinnett County Parks and Recreation facilities must ensure that no persons be
  denied participation in any park or programs based on race, color, national origin, religious background, sex or age and be in
  compliance with the Americans with Disabilities Act
- 4. Gwinnett County Athletic Associations may not limit participation or otherwise discriminate against participants based on their proximity to or away from school clusters. Gwinnett County's parks are for the enjoyment of everyone in the community and are not assigned by school clusters
- 5. The association's activities on Gwinnett County facilities must have a sufficient number of adults present to supervise all scheduled activities from the time the youth arrive until every boy or girl has left the area
- 6. The association is responsible for any damage incurred to the facilities while in use. Persistent damage could result in revocation of a portion of or the entire permit
- 7. The association is responsible for spectators, parents, coaches and participants. A display of conduct that is unbecoming while said association is using County facilities could result in written reprimand or revocation of usage privileges
- 8. The association must not and cannot reassign this permit at any time
- 9. Gwinnett County Parks and Recreation reserves the right to alter this permit at any time
- 10. The organization must provide Gwinnett County staff with written, itemized practice and game schedules prior to any authorized use of fields and/or facilities. Failure to do so will result in loss of usage privileges.
- 11. The association must clean up the general area used when finished
- 12. The association must properly put away any tables, chairs, or other equipment that was used
- 13. The association must adhere to any facility rules
- 14. Only scotch or masking tape may be used for decorations and signage. Nothing may be hung from the rafters, light fixtures, window blinds, or curtains
- 15. All decorations, signs, etc. must be removed from the facility at the conclusion of the rental

- 16. In the case of inclement weather, cancellations are not assumed; notification by the User is required
