

FORSYTH COUNTY PARKS AND RECREATION DEPARTMENT  
FIELD RESERVATION

The Atlanta Cricket League has the Fields listed below reserved for Cricket practices and games. This reservation will be good for the dates listed along with each specific site. Atlanta Cricket League may use the fields and its activities may begin at 7:00 am and must conclude as noted on each date listed below.

This reservation is contingent on The Atlanta Cricket League group abiding by certain stipulations:

1. All participants must provide their own insurance. The FCPRD will assume no liability as it relates to participants or equipment.
2. The FCPRD will not provide any equipment, or special markings on fields related to this activity.
3. The FCPRD will review this agreement at the 1<sup>st</sup> of each month to determine if the reservation's requirements are being met and if the reservation will remain "active".
4. The FCPRD will monitor field condition for damage created by the activity. Any evidence of sever or long-term damage to FCPRD fields or facilities may result in cancelation of this agreement.
5. The Atlanta Cricket League will be responsible for cleaning the area around each field and placing trash in appropriate receptacles prior to vacating the premises. Additionally, all participants must abide by FCPRD Code of Conduct. A copy of the Code of Conduct copied below.
6. Each date/field rental fee will be \$300.00, 25 dates at \$300.00 will total \$7500.00
7. The FCPRD reserves the right to cancel scheduled activity due to poor weather, field conditions or other "Acts of God".

The "total fee" for all practices and games may be paid in 2 installments. One payment (1/2 of the total) should be paid prior to 3-31-24, and the balance to be paid no later than 12-1-24.

Failure to abide by any part of this agreement will result in cancellation with no refund.

**Code of Conduct:**

For all FCPRD competitions, positive cheering by players, coaches and spectators is encouraged. Any negative cheering/actions may result in a warning and/or removal from the site, whether it is for or against "your" team. No artificial noisemakers (i.e., cow bells, air horns, etc.) shall be allowed in the dugouts, bleachers, seats and standing areas around the perimeter of the competition in any sport(s). The FCPRD Staff is empowered with the authority to take action towards those that violate this policy.

**By registering for an athletic program, volunteering as a coach, serving as a game official, or attending an event as a spectator, all participants agree to abide by the following Code of Conduct. Failure to abide by the Code of Conduct may jeopardize yours and/or your child's opportunity to participate in any FCPRD's athletic programs.**

**Youth Athletic Code of Conduct:**

- I will remember that youth athletics are for the children and not the adults.
- I will do my best to provide a safe environment for all youth participants.
- I will review and practice basic first aid principles and emergency procedures.
- I will place the emotional and physical well-being of my players ahead of a personal desire to win.
- I will treat all players, coaches, parents, officials, and spectators with respect.
- I will know, understand, teach, and abide by the rules of the game.
- I will refrain from using drugs, alcohol, and tobacco at or during youth athletic events.
- I will not engage in any behavior which would endanger the health, safety, or well-being of any participant.
- I will not engage in any verbal or physical threats or abuse aimed at any participant.
- I will not engage in the use of profanity.
- I will not engage, encourage, or participate in a fight or scuffle with any participant.


**Adult Athletic Code of Conduct:**


- I will remember adult athletic participation should be about fun and fellowship with my teammates.
- I will do my best to display and promote good sportsmanship at all times.
- I will treat all players, coaches, officials, and spectators with respect.
- I will know, understand, and abide by the rules of the game.
- I will not engage in any behavior which would endanger the health, safety, or well-being of any participant.
- I will not engage in any verbal or physical threats or abuse aimed at any participant.
- I will not engage in the use of profanity.
- I will not engage, encourage, or participate in a fight or scuffle with any participant.

**Disciplinary Action:**

Anyone that fails to abide by the FCPRD's Code of Conduct while attending, coaching, officiating, or participating in an FCPRD sports event will be subject to disciplinary action including but not limited to the following in any order or combination.

- Violators may receive a verbal warning from FCPRD staff.
- Violators may receive a written warning from FCPRD staff.
- Violators may receive an immediate ejection from event and/or park from FCPRD staff.
- Violators may be placed on probation.
- Violators may be suspended from event(s) and/or parks(s).
